General:

1. The bid form has been revised for several additional Appendices.
2. A separate section has been provided for entering the gymnasium LED video wall costs. Contractors are requested to break out the video wall costs and include them on this line. All of the video input infrastructure (Visionary Solutions Encoders and Decoders) should remain as part of the AV bid (274116 Appendix A) so that these components maintain their consistency across the project. This will provide an HDMI output at the rack that can be plugged into the video wall processor.
3. The AV (274116) contract will include the work up to the HDMI output which will be a 1080p video signal via HDMI. The LED video wall processor must be able to accept 1080p HDMI.

4. The video wall shall be a nominal height of 16' x 9' and will have a native resolution of 1920 pixels x 1080 pixels (nominal pixel pitch of 2.5mm). Include all frames, hardware, covers, caps, and mounting accessories.
5. Bids for the LED video wall section should include the LED wall, processor/driver, and any required media players or other hardware.

Specifications:

1. Section 116632 Interior Scoreboards
 - a. Part 2.2.E.1 – The district would like to have programmable names for home and guest as noted in the accessory equipment. Remove the vinyl applied captions from this section.
 - b. Part 2.5.A – Add the following language:
 - i. At each fixed scoreboard, contractor to supply a custom signage element above the scoreboard to match the school name/mascot/slogan. Successful contractor shall submit suitable and appropriate design options for review by the district and shall supply a color rendering of the selected design option for approval.
2. Section 274116 Installed Audio-Video Systems
 - a. Part 1.4.A.11 – Revise as follows:
 - i. (2) Apple TV (provided by school) w/ (2) contractor furnished AVoIP input boxes
 - b. Appendix A – Remove the costs associated with the LED video wall from this section and enter these costs under the “LED Video Wall” costs on the bid form.
 - c. Appendix C – Revise the quantity of OFE Apple TV devices and associated encoders to a quantity of (2).
